I. INTRODUCTION

The Office of the Comptroller of the Treasury was established in 1851. The Comptroller is elected by popular vote of the people for a term of four years. He has general superintendence of the fiscal matters of the State of Maryland. The Comptroller's Office is responsible for the collection of taxes, the protection of revenues, and the general administration of the State of Maryland tax laws.

The Comptroller of Maryland is divided into divisions and several specialized units. Divisions within the Comptroller's Office are the Compliance Division, Revenue Administration Division, Information Technology Division, General Accounting Division, and the Field Enforcement Division. The administration of the division is the responsibility of the respective director, assisted by deputy and/or assistant directors.

The Field Enforcement Division is the enforcement arm of the Comptroller of Maryland and is generally responsible for the enforcement of Maryland's revenue laws relating to motor fuels, alcoholic beverages, cigarettes, other tobacco products, business licenses, transient vendors, certain authorized slot machines, and collection of sales and use taxes. It is comprised of various sections – Enforcement Agents; Compliance Inspectors; Motor Fuel, Alcohol, and Tobacco Tax regulators; the State License Bureau; the Motor Fuel Testing Lab; and Regulatory Licensing Group.

The Enforcement Agents and Compliance Inspectors are responsible for the detection and enforcement of the revenue laws relating to alcoholic beverages, tobacco taxes, motor fuel (including International Fuel Tax Agreement (IFTA) and motor carriers) and sales and use taxes. The tasks performed to complete this function include conducting investigations, arresting violators, and performing compliance inspections for proper licenses. The regulatory function of the Division regulates the businesses engaged in the motor fuel and lubricant industry, motor carrier industry (IFTA), the alcohol industry, and the tobacco industry. The State License Bureau is responsible for the administration of all State business licenses and coordinating license issues with the Clerks of the Court, statewide. The Motor Fuel Lab is responsible for testing motor fuel to ensure the quality and safety of the fuel sold to consumers across the state. They are also responsible for testing alcohol when needed. The Regulatory Licensing Group is responsible for regulatory and legal work related to motor fuel tax and licensure, alcoholic beverages tax and licensure, tobacco tax and licensure and motor carrier tax and licensure.

 policies and procedures and continual evaluation and revision of these policies and procedures when
 appropriate.
