### **Look for Savings During Annual Shop Maryland Tax-Free Week August 8-14**

Shop Maryland Tax-Free Week returns August 8-14 with significant savings for consumers, scholarship opportunities for college and trade school students, and a much-needed sales boost for retailers.

During the week, any single [qualifying article of clothing or footwear](#) priced **\$100** or less – regardless of how many items are purchased in the same transaction – will be exempt from the state's six percent sales tax. The first \$40 of any

### **Pandemic Workgroup Probes Unemployment Insurance Delays, Customer Service Failures and Fraud**

At the third meeting of the Comptroller's Workgroup on Pandemic Spending July 29, Comptroller Franchot demanded answers about the state's troubled unemployment insurance system that has prevented tens of thousands of Marylanders from getting the financial assistance they are owed.

David McGlone, deputy secretary for the state Department of Labor, said the agency has paid out almost \$13.2 billion in state and federal claims to more than 675,000 Marylanders since March 2020. More than 20,000 claims currently


Despite spending tens of millions of dollars in emergency contracts to hire more call center operators and claims agents, customer service woes continue.

## More Than 3 Million Returns Processed; \$2.3 Billion in Refunds Sent to Taxpayers

The Maryland Comptroller's Office has processed more than three million state tax returns for the 2020 tax year, with 90 percent of returns filed electronically. More than \$2.3 billion in refunds has been returned to 2.3 million Maryland taxpayers, with the average

“We know families rely on those refunds as a lifeline, to pay credit card bills and to do small projects around their house,” Comptroller Franchot said. “We try to get refunds back into the pockets of hard-working taxpayers as soon as possible, typically in less than three business days and deposited directly into their bank accounts.”
